## Public Cloud Junior Systems Administrator for Azure

#### Public Cloud Specialist I

The Mississippi Department of Information Technology Services (ITS) is seeking a qualified person to fill the role of a Public Cloud Junior Systems Administrator for Microsoft Azure to support our enterprise hosted cloud environment built on commercial public cloud infrastructure. Desirable candidates have a degree or applicable experience in information technology or a related field; and have some experience administering, configuring, and troubleshooting Microsoft Azure public cloud infrastructure.

### Key Responsibilities

This position will work in the Enterprise Public Cloud team of the Data Services division at ITS. The Public Cloud team's purpose is to deliver, monitor, and support cloud services hosted within commercial public cloud infrastructure and is responsible for critical escalated support in a shared on-call duty.

This role is involved in the configuration, troubleshooting, and ongoing maintenance of all tools needed to support enterprise public cloud services. In all capacities, the person filling this role works directly with operations staff, system specialists, agency technical staff, public cloud staff, and external contractors to ensure consistent delivery of related cloud services.

- Collaborate with cross-functional teams to design and implement scalable, secure, and highly available cloud-based solutions on Microsoft Azure
- Work with various Azure Cloud services and understand the service offerings and best practices of each
- Work directly with agencies to onboard them to the Azure Cloud, and to create accounts and secure workload areas.
- Monitor agencies' monthly utilization and billing to ensure enterprise cost efficiencies
- Help to automate the deployment, management, and ongoing administration of cloud infrastructure on the Azure Cloud
- Work with 3<sup>rd</sup> party vendors for architecture, integration, and support of cloud services
- Monitor and troubleshoot Azure Cloud-based systems and applications
- Stay up to date with the latest trends and developments in cloud computing
